Soon, I will reach out to LE teams for feedback and also contact someone from OH. If the numbers warrant such, it may be good to run an event closer to home.

b. LC Age Group at SPIRE: 2/3 of the BOBs are confirmed. Kat is likely "in" but still tentative, pending Joey's college choice etc.

Since LC champs is at SPIRE, please advise if the district will be providing housing /or housing stipends for the meet directors as they have in the past.
Looking forward into 2020, I would like to re-initiate a discussion with FAST to host LC Senior champs again. I have some ideas that we can discuss later.
