 - As officials, the ability to officiate meets well will not be helped with the proposed merger, impacting the assignments and decreasing the minimum number of officials on deck.
 - 2. Officials who are qualified will likely not work without the nominal fee that covers gas, food, etc.
 - 3. There is a concern for smaller clubs who may struggle to find officials outside of their own club to mitigate bias.
 - 4. There does not seem to be a benefit to most teams and athletes, especially those who favor dual meets that are closer to home. A merger is not needed for the benefits of those who wish to travel for more challenging competition.
