Announcements (Vince Colwell – General Chair)

- 1. National HOD will now be made up of 40% athletes; 40% coaches; 20% non-athlete and non-coach
- 2. DEI Chair must be a part of LSC Board of Directors so we have to elect a DEI Chair.
- 3. LE will look into the Developmental meet info that was discussed at USA Swimming HOD.

- 1. Legislation
 - a. The Athletes proposed the legislation below for several reasons
 - Understand that diversity among teams is important but do not want location/teams to dictate these committees; Would like all athlete who are willing to participate be able to participate; quality representation should take precedent over location/teams
 - ii. This is only a recommendation that athletes be from different teams, instead of required
- 2. MOTION: Approve the legislation (6.2.1) as presented. PASSED 53 in favor; 8 opposed
- 3. MOTION: Approve the legislation (7.4.1) as presented. PASSED 53 in favor; 7 opposed

Location: LESI Bylaws

Proposed by: Megan Maholic, Board of Directors Athlete At-Large, Madison Machado, Lake Erie Junior Athlete Representative, and Zach Toothman, Lake Erie Athlete At-Large

Purpose: To eliminate discrimination in athlete representative elections and to allow the athletes to select their representatives based on who they believe will do the best job rather than those that fit a certain description.

6.2 OTHER DIRECTORS

.1 ATHLETE REPRESENTATIVES - Two (2) Athlete Representatives shall be elected, one each year for a two-year term, or until their respective successors are elected. At the time of election, the Athlete Representative must (a) be an athlete member in good standing; (b) be at least a sophomore in high school or at least 16 years of age, (c) be currently competing, or have competed within the three (3) immediately preceding years, in the program of swimming conducted by LESI or another LSC; and (d) have his or her place of permanent residence in the Territory and expect to reside therein throughout at least the first half of the term (other than periods of enrollment in an institution of higher education). The balloting shall take place at a meeting called for that purpose by the Senior Athlete Representative, or failing that, at a time and in a manner designated by the Board of Directors. At least twenty (20) days' written notice of the election shall be given to all clubs. The Athlete Representatives elected shall be determined by a majority of the members of the Athletes Committee present and voting. In no case shall It is recommended, but not required, that the Athlete Representatives be are not members of the same club.

.1 ATHLETES COMMITTEE

C. [No changes]

ATHLETES EXECUTIVE COMMITTEE - There shall also be established an Athletes Executive Committee.

1. [No changes]

(2) MEMBERS – The Athletes Executive Committee shall consist of the Athlete Representatives, the Athlete-At-Large Board members and four (4) additional athletes, who are elected as follows and who may be a club member's athlete representative to the House of Delegates. Two such additional athletes shall be elected each year for two-year terms, or until their respective successors are elected. At the time of election, such additional athletes must (a) be athlete members in good standing; (b) be rising freshmen, sophomores or juniors in high school, (c) be currently competing, or have competed within the immediately preceding year in the program of swimming conducted by LESI or another LSC; and (d) have their place of permanent residence in the Territory and expect to reside therein throughout at least the first half of the term (other than periods of enrollment in an institution of higher education). The balloting shall take place at the meeting of the Athletes Committee prior to the annual meeting of the House of Delegates. Such additional athletes elected shall be determined by a majority of the members of the Athletes Committee present and voting. It is recommended, but not required, that No more than two (2) of the additional athletes shall be members of the same club.

Approval of 2022 Budget – PASSED as presented by Mark Kruisinski with combining Zone Workshops and Convention expenses into one line item in the amount of \$9640.00

- a. Mark Kruisinski noted the following
 - i. **Swimmer Surcharge** and **Sanction Fees** are projected to be about 95% of 2019 Actual Income.
 - ii. **USA Registrations** are projected based upon 4,000 athletes and 300 non athletes. Actual Athlete Registrations were 4,577 for 2017, 4,214 for 2018 and 4,140 for 2019. Actual 2021 registrations to date are 3,370 athletes and 282 non athletes. The year after the Olympics are generally highest registration years.
 - iii. **14 & Under Central Zone Pool meet** is projected to be a 5-day meet at \$38 per athlete per day for 100 athletes. This is at pre pandemic level.
 - iv. **Age Group Camps** have been budgeted for at \$1,250 because these have been not held in 8+ years.
 - v. **Swimposium** is budgeted at \$2,500 since this is to be done every three years.
 - vi. **Officials Training Recruitment** has an increased budget amount of \$1,000 because of the need to increase the officials in LESI
 - vii. **Officials National Qualifying Meet Evaluators** are budgeted at \$1,000. This is what was spent in 2021 at Summer Sectionals.
 - viii. Volunteer Recognition is budgeted at \$1,200 even though nothing was done in 2020 or 2021.
 - ix. Awards Program is budgeted as an in-person program with a meal.
 - x. Elaine Miller is assumed to be consistent at \$10,000.
 - xi. **Learn to Swim Program Support** is budged at \$4,000 as a possible new program. This should be a discussion item
 - xii. **Club Incentive** is budgeted at \$2,000, as a new program.
 - xiii. **Travel Reimbursements for National Level Meets** have been budgeted for at 2019 (pre pandemic) participation levels.
 - xiv. All Clinics/Meetings including USAS Convention are budgeted for as in person events.
 - xv. **Permanent Office** has a proposed 5% raise. No raise has been awarded in the past 3 years.

- Send sanction application and meet information directly to Pam Cook
- If you are hosting a meet that is NOT on the LE meet schedule, you MUST include the names of the officials doing your meet on your sanction application or the meet cannot be sanctioned.
- Sanction applications and meet information should be submitted in a timely manner
- Pam Cook will send an invoice for \$100 for meets not on the LE schedule after the meet is sanctioned. Non schedule meets must pay a \$100 fee for the meet when no entry fees are taken
- Meet Manager backups need to be send to Pam Cook prior to all meets (scheduled or non scheduled meets) and after the meet is over
- Event files must be sent to Pam Cook for LE schedule meets
- Payment for surcharges must be sent to Diane Finnerty within 14 days after the meet
- Payment of sanction fees must be sent to Diane Finnerty within 45 days after the meet in addition to the financial statement
