      - O Coaches do not emphasize it enough
      - O Even though the IMX is part of the Club Incentive Program, it is individual focused instead of team focused

- 3. OTC Camp Additional Funding Request
  - **a.** HOD passed \$6,480
  - b. Request for \$15,352.76 plus video fees to fully cover costs for Coaches (Airfare + Room/Board) and Athletes (Room/Board); This amount is based on 20 athletes and 4 coaches Motion to approve requested \$15,352.76 to fully cover costs to go to Olympic Training Camp: SECONDED

Discussion:

- When this was originally introduced several years ago, the request was \$4000 because OTC covered a lot of expenses.
- The cost of room and board has gone up and they are not funding it like they used to.
- Coaches estimated airfare is around \$2001 for 4 coaches.
- Room and board for 20 athletes and 4 coaches is over \$13000
- This will not cover videotaping and processing fee for athletes
- The current list of current coaches does not include any women
- Athletes are paying for their own airfare
- There is too much money allotted for the coaches and not enough for the athletes; \$4500 of the current the \$6000+ is to shoulder coaches' expense
- LSC does not need to fund 4 coaches. If more coaches want to go, the coaches can decide how shoulder the rest of the expenses

- There are no strict criteria as to who can go to the Camp. Originally, this was supposed to encourage 13-15 year old swimmers to go so they can bring something back to the LSC. Now, there are college bound athletes who want to go and may never contribute to this LSC again.
- There are no restrictions on number to go except that 20 is the maximum number the OTC will allow per LSC
- Compared to national meets where the airfare is covered by the LSC and hotel stay is not, perhaps the LSC can ask the athletes to pay a little bit of the room and board
- Friendly amendment to the motion:
  - O Include a female coach
  - O Fund entire cost for 2 coaches
  - O Fund ½ of athletes room and board
  - O Include funding for processing and videotaping

Motion: Increase the original budget for OTC to include: full funding (airfare, room and board) for 2 coaches (according to LSC's travel policy), ½ of the room and board for athletes, processing fee and videotaping not to exceed \$8500: PASSED

#### **Discussion Items**

- 1. Black History Meets
  - There is money budgeted for 2 meets (\$2000)
  - Tom will talk to the Diversity Chair (Mike and Carrie) regarding holding meets
- 2. Safe Sport Chair Legislation
  - Legislation needs to be done in the Spring to make Safe Sport Chair as a voting member of the Board
- 3. LSC Coach Mentorship Program
  - We can submit for funding for this program
  - LSC needs willing participants, plenty of coaches willing to be mentors
  - Matt should create a mentoring program
- 4. Mighty Mid Size Workshops:
  - Performance of the LSC compared to other clubs:
    - a. Tom has a handout which shows the performance of all the LSC's
    - b. Previously, LESI was below average performance of the national average based on NAG times
    - C. In LC, 18 and unders were below average in 6 of the 9 categories
    - d. LESI is now above the national average in 5 out of 9 categories
    - **e.** The 15-18 year old LC meters times is only slightly above National average and only slightly higher than the BB cut
  - There is a new on line governance course that Tom would like the Board to take. He will send the link.
  - They are also explored the possibility of changing the Nominating Committee to a Governance Committee. This committee which will be separate and independent of the Board will look into the succession of not only the Board members but may make suggestions regarding the governance of the LSC.

- Regarding Camps, we should have more substantive programs that USA can fund
- While is our LSC is classified as a mid sized lsc, LE is way ahead of many of the other lsc's with regards to governance structure, LEAP status, consent agenda and other procedures that our LSC takes for granted

- 3. Admin Vice-Chair- Chuck
  - Awards never made contact with Diana Munz after many tries by me, Sarah and Jim Bocci, so we are exploring other possible speakers.
  - Sanction still have not sanctioned either Senior or Age Group Champs which were supposed to be done in time for Fall HOD. Don't Go Breakin My Heart Meet is past due. We have sanctioned or approved 14 meets that were not on the schedule, with one more in the hopper. Intrasquad, dual and tri meets have become a staple for many of the clubs as an inexpensive way for their swimmers to get official times. Someone might want to study the impact of such meets on participation in scheduled meets as well as the financial impact (re sanction and surcharge income).

### 4. Senior- Mike

- a. Raise IMX Score get a score
- b. Increase National level participation.
  - Lake Erie has been represented at all National level meets in 2015
  - Looking ahead Olympic Trials 2016
    - Currently 12 LE swimmers qualified in 23 events.
    - ➤ LE had 13 swimmers qualified in 19 events in 2012.
    - ➤ 2016: 4 Male/8 Female
    - ➤ 2012: 6 Male/7 Female
    - ➤ College/Foreign athletes included in both totals.
    - Trends show us that swimming is getting faster in LE.

- Many swimmers qualified for 2012 Trials in the last months of the qualifying period in 2012. We could see the same trend in 2016
- **C.** Increase average ranking of Clubs in the Virtual Champs
  - This was covered at HOD.
- d. Increase college involvement.
  - Increase in Lake Erie participation from University of Akron improved the quality of our senior championship meets. Hope to see this trend continue amongst other college programs.
  - College coaches' roundtable was held during Swimposium, educating athletes on the college recruitment process.

## 5. Age Group- Bill

• There was some discussion, in response to a question from Technical Planning, on what could be done to help improve AG swimming and achieve more of the strategic objectives. A few ideas emerged that had to with the LSC sponsoring a zone prep team. This would be geared towards kids that are close to qualifying for zones and potentially being sponsored for a regional travel meet. Another idea was for a representative of the Zone team to reach out to all of the teams in the LSC and specifically to kids close to making the meet. The intention would be to inspire the kids. Discussion is still ongoing.

Sam reported that he has forwarded the budget for the Olympic Training Center trip to Rich. The final roster of kids that will be attending the OTC is still being finalized. Eric Peterson, Matt Davis and Carl Schallenberger have been assigned so far. One more coach needs to be assigned.
