- o The object of FLEX membership is to bridge the gap between swim lesson swimmers and year round USA swimmers. It entitles them to participate in 2 sanctioned meets per membership year. Flex members may not compete at or above the LSC Championship level. An athlete member shall not be registered in more than one LSC simultaneously. Flex members who transition to the Annual athlete membership category within the same calendar year will be able to credit the Flex athlete membership cost to the Annual athlete membership cost.
- o Jr. Coaches are coaches who need to fulfill all the requirements of a regular coach without the background check. These are for coaches 16 and 17 years of age.
