# Approval of minutes from April 2014 HOD Meeting: Passed

#### **Announcements**

- 1. Updated from the 2014 USAS Convention- Tina McCauley (see LESI website for Powerpoint presentation)
  - Congratulations to Julie Bare who received the Kenneth J Pettigrew award at national level which is the highest award given to an official
  - Ross Palazzo did a presentation on how LESI athletes do community service and run their own clinics for athletes at Convention
  - TY to Ross for coordinating HS swimmers for parade of athletes during Age Group Champs
  - LESI was presented a check for achieving Leap 3 in the first quad. The lsc has achieved Leap 1 and 2 for the 2<sup>nd</sup> quad and currently working on achieving Leap 3
  - Senior Development Committee: Legends (Futures) Meet was passed at Convention. LESI will be in the East and the meet will be held at Greensboro, NC. Our Section (Section 3) has slower cuts compared to the rest of the country. Cuts will be between Sectionals and Jr. Nat'l cuts (5-10% slower than J Nat times).
  - Central Zones Senior meet was voted that it will not continue moving forward and SC Jr. National meet will be held in 2 sites
  - Age Group Development Committee: Age Group Progression is on draft form and expected to be published by fall.
  - Legislation was passed at Convention to ban deck changing. LESI is looking at ways to enforce this legislation.
     Currently, any athlete seen changing on deck will be reported to referee and the issue will be dealt then. Please educate athletes of this legislation.
  - Central Zone meeting: The 14U Zone Meet will be from August 7-9, 2015 in Minneapolis, MN. Steve has started to make arrangements
  - IUPUI will host the Mega Zone in August 4-7, 2016 (15 lsc's in 1 meet)
  - Central Mutlicultural Camp will be June 16-19, 2016 in Omaha, NE. It will be 1 week prior to Olympic Trials.
  - Central Zones Open Water Meet is June 18-19, 2016 at Pleasant Prairie, WI. The 5 k will be an Open event a 15-16 800/1500 A time as qualifying time.
  - Central Zone Select camp is being considered to be held at Ohio
  - Fran Crippen Cup will be held at Ft. Meyers, FL on April 12, 2015
- 2. LESI Records clarification: LESI will maintain the current LESI records with 10U, 11-12, 13-14 etc categories and have single age meet records. These meet records are eligible to be LESI records.
- 3. Sanctioning Process: Teams who are hosting meets must meet deadlines as written in the By-laws. Any team who is late in submitting their meet information will be fined. When applying for a sanction meet, the host team should have a registered official/official in training and registered meet director. Safety directors do not need to be registered.
- 4. Meet volunteer assignments for Age Group Champs will be posted on the LESI website. Meet directors will no longer email entry chairs, coaches and volunteer chairs. Each team will be asked to provide a contact person during the meet. If no one from the team is there to serve as liaison, the coach will be expected to perform that duty.

- 5. Coach Mentoring Program: There are currently 5 mentors: Mike Davidson, Matt Davis, Eric Peterson, Mike Griggs and Tim Hable. There are 2 more spots available. Please see Eva if interested in becoming a Coach Mentor.
- 6. Olympic Training Center Trip- See Sam Seiple's Report
  - TY to LESI for support in sending contingent to Denver
  - John Elliott put the trip together; Mike run the website all week posting daily activities.
  - Mike Davidson, Sam Seiple and 20 swimmers went
  - Local (Canton) radio station interviewed Sam and Canton school districts followed their daily blogs and posts.
  - TYR and USA swimming gave both athletes and coaches free stuff
  - There were 6 days of all day training consisting of dryland, lectures by Mark Hesse and Harriett Gunnderson. Dave Denniston who is the USA Paralympic team coach gave a very inspirational talk.
  - Athletes swam an average of 10-12 k m/day. There were a sprint, IM and distance groups with coach rotating through groups
  - Athletes got taped and brought this home. Athletes had lectures on nutrition, race prep, goal setting and race starts.
  - Off site trips were to the Air Force Academy and Garden of the Gods. Wounded Warriors with their service dogs trained all week with to get ready for the Warrior Games
  - USA Swimming has put together a movie that will be released in theatres.
- 7. Disability Swimming: There are lots of opportunities for swimming at the lsc and Central Zone level. Please let her know of any disability athlete. Working with Michigan Disability lsc to increase awareness of disability swimming.

Proposed by:	Lake Erie Board of Directors
Purpose:	To provide all 13 & over athlete members a fair opportunity to vote for their athlete representatives within Lake Erie Swimming. 604.1.3 is being renumbered to allow for a clearer understanding of the language.
Recommendation:	The Legislative Committee for LESI recommends that this proposal be adopted.

# Effective date: immediately

- MEMBERS- The House of Delegates of LESI shall consist of the Group Member Representatives, the Athlete Representatives, the Coach Representatives, the Board Members designated in Section 605.1, the At-Large Board Members designated in Section 605.2, the Ex-Officio Members designated in Section 605.3, and the At-Large House Members.
  - .1 (NO CHANGE)
  - .2 (NO CHANGE)
  - .3 ATHLETE REPRESENTATIVES Two (2) Athlete Representatives shall be elected, one each year for a two-year term, or until their respective successors are elected. At the time of election, the Athlete Representative must (a) be an Athlete Member in good standing; (b) be at least sixteen (16) years of age or at least a sophomore in high school; (c) be currently competing, or have competed during the three (3) immediately preceding years, in the program of swimming conducted by LESI or another LSC; and (d) have his or her place of permanent residence in the Territory and expect to reside therein throughout at least the first half of the term (other than periods of enrollment in an institution of higher education).
    - A. The election of the Athlete Representative shall be conducted annually during LESI's short course swimming championship, or other regularly scheduled meet designated by the Board of Directors. Prior to the election, the current Athlete Representatives and the Athletes Committee shall be asked to nominate one or more Athlete Members for consideration.
    - B. The balloting shall take place at a-scheduled meetings, conducted by each Club Athlete Representative, that will accommodate and provide an opportunity to vote to all of that team's swimmers aged 13 or older. Each club's balloting meeting must be made public to all nominees so to allow any nominees the opportunity to attend any or all balloting meetings to present their candidacy to the voting members. If a nominee cannot attend a balloting meeting they are entitled to provide the hosting Club Athlete Representative information to present on the nominee's behalf. The Athlete Representative elected shall be determined by a majority of the Athlete Members and Seasonal Athlete Members in good standing present and voting who are thirteen (13) years of age or older.
    - C. All Club Athlete Representatives will present the collected ballots from their clubs at a meeting called by the Senior Athlete Representative or the Athletes Committee, or failing that, at a time and in a manner designated by the Board of Directors- for that- the purpose of tallying all individual ballots. by the Senior Athlete Representative or the Athletes Committee, or failing that, at a time and in a manner designated by the Board of Directors. The Athlete Representatives elected shall be determined by a majority of the Athlete Members and Seasonal Athlete Members in good standing present and voting who are thirteen (13) years of age or older. Prior to the election, the current Athlete Representatives and the Athletes Committee shall be asked to nominate one or more Athlete Members for consideration.

D. The election results will be announced at the Spring Awards Banquet or Spring House of Delegates meeting.

  - B. competed in at least one additional LESI sanctioned meet in the twelve months preceding the meet for which the reimbursement is being requested,
- .5 In order to be eligible for reimbursement for Olympic Trials, an athlete must have competed in at least one LESI meet in the twelve months preceding Trials.
